# DEFINITION OF FARM HUB

“Farmers hub” means a designated area where farm food and value-added products from approved sources are sold on a consignment basis for farm food producers;

# REGISTERING WITH ODAFF

1. location of the farmers market,
2. name and contact information of the manager or advisory board members for the farmers market,

# REGISTERING WITH ODAFF

3. letters of intent to sell at the farmers market from a minimum of four independent vendors of raw food products,

# REGISTERING WITH ODAFF

4. hours of operation,
5. defined geographic region of eligible vendors
6. list of benefits accepted

# REGISTERING WITH ODAFF

7. websites and social

8. copy of market guidelines or bylaws

# REQUIREMENTS

- Open for business at least one day a week and at least four months of the year;
- Open to the general public for purchase of products;



# REQUIREMENTS

- Compliance with all local, state and federal laws regarding retail sales including, but not limited to, tax compliance and all licensing from state and federal entities;

# REQUIREMENTS

- Nonfood items are allowed, only if those items account for less than twenty-five percent (25%) of the overall sales at the farmers market;

# REQUIREMENTS

Display proper identification of the product

- name of the product,
- business or farm name
- address of where the product was grown or processed;



# REQUIREMENTS

Maintain separate sales logs for products sold on consignment for a minimum of two years including:

a. the name of the consigning farm food producer or value-added processor,

# REQUIREMENTS

- b. the address, telephone number and other contact information of the consigning farm food producer or value-added processor,
- c. specific items sold on consignment, and
- d. quantity of items sold on consignment;
